ADMISSION TO MEMBERSHIP

6. (1) A person who desires membership of the Association may lodge with the Secretary a written, signed, and dated application in that behalf, addressed to the Committee, and therewith shall lodge by way of tender a sum equal to the amount of the annual Subscription or donation then current for the classification of the Membership that the person desires and for which sum an interim receipt shall be issued.
- (2) The Secretary shall lay each application for Membership before the meeting of the Committee held next after receipt thereof.
- (3) The Committee may in its discretion, deal with an application at the meeting during which the same is laid before it, or at a subsequent meeting of the Committee, or at a resumed meeting of the Committee.
- (4) (a) The Committee may accept or may reject an application for Membership and shall not give reasons for either decision.
- (a) No person applying for Membership shall become a Member unless the Committee shall accept that person's application.
- (b) The Secretary shall send to the applicant written notification of the decision of the Committee, and if the application has been rejected shall return the sum paid by way of tender.
- (c) The Secretary is to enter the applicant's name in the Register of Members on the acceptance of an application for Membership.
